Type Approved Land Mobile radio equipment for use on the VKS-737 Radio Network

Equipment used on the VKS-737 Radio Network must be Type Approved for use on Land Mobile frequencies and must comply with standards as laid down by the Australian Communications and Media Authority and its predecessors.

Relevant Standards include:

- RB 209 (December 1970, January 1974, January 1976),
- DOC 209 (October 1988), ECR 209 (April 1992),
- Radiocommunications (MF and HF equipment Land Mobile Service) Standard 2003,
- Australian / New Zealand Standard AS/NZS 4770:2000

Compliance with the relevant standards will either take the form of a compliance label or plate on the equipment.

Important aspects of equipment authorised for use under the Land Mobile Licence are:

- Must meet the technical requirements (i.e. transmit power, frequency stability, spurious emission limits etc.)
- Must be suitable for operation by unskilled persons,
- Must not operate, or permit operation of, the transmitter except on frequencies as specified in the licence.
- The use of amateur radio equipment modified to allow transmission on Land Mobile frequencies is prohibited.

Further information on licensing conditions can be found in the Radiocommunications Act No. 174 of 1992 and Radiocommunications Licence Conditions (Land Mobile Licence) Determination No. 1 of 1997.

Any of the above Selcall optioned or Non-Selcall radios can be fitted with a Jenal SC2 Selcall/Telcall Microphone or a Jenal SC3 Telcall Microphone to enable selcall contact with VKS-737 Bases.

Overseas (9360) or Marine (9390) variants of the Codan 9323, and Overseas (SR & VR) variants of the Codan NGT are NOT type approved for use in Australia and cannot be used on the VKS-737 Radio Network.

It is an offence, and subject to a civil penalty, to operate a radiocommunications device otherwise than as authorised by a spectrum licence, apparatus licence or a class licence (section 46 of the Act). The Act prescribes the following maximum penalties for the offence:

- if the radiocommunications device is a radiocommunications transmitter, and the offender is an individual imprisonment for 2 years;
- if the radiocommunications device is a radiocommunications transmitter, and the offender is not an individual 1,500 penalty units (which is \$333,000 based on the current* penalty unit amount of \$222);
- if the radiocommunications device is not a radiocommunications transmitter 20 penalty units (\$4,400).

The Act prescribes the following maximum civil penalties:

- if the radiocommunications device is a radiocommunications transmitter 300 penalty units (\$66,600);
- if the radiocommunications device is not a radiocommunications transmitter 20 penalty units (\$4,400).

It is an offence, and subject to a civil penalty, to possess a radiocommunications device for the purpose of operating the device otherwise than as authorised by a spectrum licence, apparatus licence or class licence (section 47 of the Act). The Act prescribes the same penalties for this offence and civil penalty contravention as for the offence and civil penalty contravention in section 46.
